USE OF CABANA RULES – 9AM – 9AM (Building to be vacated by 9:30 pm)

Members may reserve the Cabana by signing up at the clubhouse. A member must be present when using the Cabana and be responsible for complying with the "Cabana Use Rules".

- No reservations will be accepted prior to January 1st for each year.
 - Reservation fee is non-refundable in case of cancellation
 - There are certain dates that the Cabana cannot be reserved
 - Please check with a staff member for availability or if you have any questions @ 541-764-2495.
1. A \$50.00 non-refundable reservation fee is required for each day requested and payable at the time of reservation. The CSBC Board may approve some exceptions at their discretion.
 2. A \$50.00 cleaning damage deposit is required (for each day requested) payable no later than one week prior to the cabana reservation date. If the cabana is left clean, without damage and generated trash is removed from property by member the cleaning deposit check will be returned within two weeks. Any damage over \$50.00 will be billed to the property owner.
 3. All food must be removed including the refrigerated items. Failure to remove garbage/food will result in the forfeiture of the cabana cleaning deposit.
 4. In order to operate the range, you must request the range pigtail (plug) at the time of making your reservation.
 5. Directions for operation of the wood stove are located next to the stove. You must supply your own wood. Split wood should be used in the stove.
 6. Sand is not to be put down sink drains or toilets. Use outside faucets for rinsing feet, shoes, clothing, etc.
 7. Members must ensure that no one climbs on banks, riprap, or beach grass, or in any way abuses club facilities and property.
 8. Supplies in the unlocked cupboards may be used; detergent, cleanser, sponges, etc.
 9. The noise level must be kept low enough so other members are not disturbed.
 10. Restrooms are to be available to other members and families during the reservation
